The County Board of Piatt County convened in the County Board Room in the Courthouse in the City of Monticello, County of Piatt and State of Illinois on Wednesday, the 12th day of September, A.D. 2018, at the hour of 9 o'clock in the morning and was called to order by Sheriff, David Hunt. On roll call the following Board Members and County Officers responded: County Board Members, Renee Fruendt, Albert Manint, Robert Murrell, Randy Shumard and Ray Spencer; Sheriff David Hunt, and County Clerk Jennifer Harper. Absent: Dale Lattz. On proclamation by Sheriff Hunt, the Honorable County Board was declared to be in session pursuant to adjournment.

#### **MINUTES**
