The County Board of Piatt County convened in the County Board Room in the Courthouse in the City of Monticello, County of Piatt and State of Illinois on Wednesday, the 14th day of November, A.D. 2018, at the hour of 9 o'clock in the morning and was called to order by County Board Chairman Albert Manint.

On roll call the following Board Members and County Officers responded: County Board Members, Renee Fruendt, Dale Lattz, Albert Manint, Robert Murrell, Randy Shumard and Ray Spencer; States Attorney Dana Rhoades and County Clerk Jennifer Harper. Sheriff David Hunt was in attendance after roll call. On proclamation by Chairman Manint, the Honorable County Board was declared to be in session pursuant to adjournment.

MINUTES

MOTION was made by Shumard, seconded by Fruendt, that the minutes of the October 10, 2018 meeting be approved as read and recorded. On voice vote, motion carried.

COUNTY TREASURER'S REPORT

ZONING ORDINANCE - VARIATION (Wayne Seifert – Sangamon Township)

Keri Nusbaum, Piatt County Zoning Officer, in and for the County of Piatt, presented an application of a Zoning Ordinance for a Variation to allow for the sale and residential use of A-C Agriculture Conservation land.
