Claims

Capital claims were presented for January \$89.05 with a balance of \$33,583.59.

Operating account expenses for January for \$62 816.38 were presented.

Eric Seibring will follow up with a stormwater drainage plan for the city to help move ahead with the parking lot. Trybom is hopeful the parking lot project will be completed in the spring.

Service Reports

There was a complaint regarding a passenger and the passenger was suspended for a week. There have been prior issues with this passenger.
